- During the public comment session, you must be sworn in before you can give comments. Each speaker will have three (3) minutes to comment and when your time expires your microphone will be muted.
- You may participate in public comment or questions by attending the virtual meeting through Zoom, either by computer or phone access. However, as required by N.J.A.C. 5:39-1.4(f), a member of the public may alternatively submit written comments by 4 p.m. on the Thursday prior to each regular meeting listed above. Such written comments may be read at the public meeting only if they are consistent with the Open Public Meetings Act and guiding regulations, pertain to an agenda item, are consistent with the Planning Board bylaws, which restrict public comment to three minutes per person.
