The current balance is \$16,572.66. Received \$1,000 annual contribution from Asbury Park. Move to accept Gail Rosewater and seconded by Doug McQueen. All approved Treasurers Report.

Department of Public Works:

Discussed issue with one of the aerators- parts have been ordered for west end- and washing of the sidewalks on Lake Avenue on the Asbury Park side completed today. Thank you to APDPW. Sink hole in beach repaired.

Pond Weed

Gail referred to email sent out to commission from CLONET, Monmouth University, about the water quality. It reflected the past year of citizen water quality testing. Jason Adolf explained to Gail that the PH reading could reflect acidity from Acid Rain. Our number is around 6.5 and 7-9 is good. Organisms cannot survive below 5. Dissolved Oxygen between a5-12 is OK. In middle of summer ours has gone low which is of concern. Our depth is also of concern. Very shallow. He indicated Wesley did not have a harmful algae bloom like other lakes. He is not sure why. Last pond weed treatment July 21, and Lyngbya and Potamogeton are suspected plants. Black Lagoon said it is the worst they have seen in three years.

Watershed and Storm Water

Next Planning Board meeting August 10th to discuss the “Triangle” development. Planning Board advocated for storm water protection measures. The issue continues to be water quantity not quality. Gail said that the developer indicted the work that had been done already in the waterfront area was a lot and should suffice: Water quality devices were put in place by Asbury Partners at Cookman, Heck, St. James, Wesley Lake Drive, Asbury Ave, Lake Ave, Kingsley, 4th, 5th and Sunset. To be done are 6th, 7th, 8th, West of Kingsley at 1st, 2nd, 3rd. Developer continues to insist that the flood issue on Lake Ave. is due to the small outflow pipe. Gail encouraged members to attend via Zoom on August 10. Gail spoke about the June 24th fuel spill. Vito said that the DEP was notified. The boom is still in the lake and that she requested a copy of the report. Doug said that the location of where the spill came from was not determined. Gail is setting up a Zoom meeting to discuss our stormwater sewer system with Peter Avakian per Doug’s request for mid-August. Info on date will be given at next meeting.

Draft Plan

In attempting to complete the 3-5 year plan requested by Donna Viero, Gail called Bellingham Docks and spoke to Jay Varga per referral from Leanne Hoffman for estimate on ADA compliant 6foot by 20-foot public dock, which is \$16,000. Eileen to follow-up on accessibility on the Asbury Park side and liability issues for dock. Plan to be voted on at next meeting.

Geese

Keith and Gail spoke on the Zoom presentation for the Asbury Park City Council work session July 8, meeting regarding the geese prevention lighting. Keith also spoke at the Sunset Commission August 4, and Deal Lake Commission July 14, meetings. Gail will request a meeting with Neptune Committee and the Ocean Grove Camp Meeting Association to discuss the lighting and address concerns.

Old Business

Tee asked if the trash cans were moved away from the storm drain on the Ocean Grove side at the Founders Park footbridge, Gail said yes.

Gail went over the suggestion from T&M after their assessment of bridges, they recommend that the footbridges not be coated as discussed at prior meetings, and to further investigate the best approach to prevent deterioration. This investigation will cost \$31,000 and both municipalities agreed to pay 50% per a Zoom meeting with Donna Viero, Doug, Eileen, Gail and Vito.

Eileen spoke to IStar about changing the weed spray used to an environmentally friendly product and they agreed. Gail mentioned that Wesley Grove is doing the same.

Gail attended the Deal Lake Commission meeting and said Asbury Park City Council approved the Manufactured Treatment Devices Installation for Deal and Sunset. Tree box placements for Asbury Park are pending and may take up to two years.

Keith brought up getting together with other lakes to develop a comprehensive joint plan for dredging. Gail said she would set up a Zoom meeting with our three lakes and Fletcher.

Motion to adjourn the meeting by Eileen Chapman and seconded by Dr. Brown. Meeting adjourned at 7:50 **PM**
